Consignment Terms and Policies

- Items accepted for consignment will be placed on sale for 30 days, up to 90 days. The consignment period begins after set prices are confirmed via email. Consignors will be contacted at the end of each 30 day period with the option to renew the contract. Items can be reclaimed at any time during the consignment period. To reclaim your items, you need to bring in your signed agreement. After 90 days, any unclaimed, unsold items become property of *The Silver Umbrella*.
- Consignor will receive 40% of the selling price. If the Consignor is an ARTIST selling their *artwork creation*, the ARTIST will receive 80% of the selling price.
- *The Silver Umbrella* reserves the right to purchase the items outright at a price designated reasonable by *The Silver Umbrella's* representative(s). The seller will receive 25% of selling price set by *The Silver Umbrella's* representative(s).
- Prices are determined by *The Silver Umbrella*. Markdowns and promotional discounts (i.e. coupons, etc.) are taken at discretion of *The Silver Umbrella*.
- *The Silver Umbrella* reserves the right to sell items on our *eBay Store* listed as a "*Buy It Now or Best Offer*" with starting prices designated by *The Silver Umbrella*. Profits for all items sold online are subjected to a 14 day wait period after a successful delivery, before payment is made.
- Consignor will be notified of items sold after the 30 day consignment period is complete and will have thirty (30) days to pick up a check from the store or to call in and make an appropriate arrangement. After thirty (30) days of inactivity by the Consignor, any remaining balance due will be forfeited and/or donated.
- Consignor represents that it is the owner of all goods consigned, has the legal right to enter into this Agreement, and guarantees that goods consigned are authentic, saleable and free of liens or other claims.
- Merchandise is left at Consignor's risk. *The Silver Umbrella* is not responsible for loss by theft, damages, negligence, or other cause. Consignor hereby waives any claims *The Silver Umbrella* – or any of its affiliates, sales agents, owners, representatives, etc. – has of the forgoing.
- No items shall be accepted without signed agreement. Items left without entering in an accepted agreement will be donated and left at the discretion of *The Silver Umbrella*.
- At each consignment appointment, a completed Inventory Intake form is required. Items will not be accepted and agreed upon without all required paperwork.
- *The Silver Umbrella* reserves the right to refuse any items without explanation.
